

## **Raisin.com/en-us Cookie Policy**

Cookies are data files placed on a device when it is used to visit Raisin.com/en-us. We use cookies at Raisin.com/en-us to improve our service for you. Some cookies we use are essential for some services to work; others are used to collect information of the use of the website (statistics) so that we can make the site more convenient and useful for you.
